After 6 days	If your child tests positive or someone in your home tests positive, meaning your child would have to self-isolate, after 24 <sup>th</sup> December you do not need to notify school until the new term begins.

#### **Free School Meals**

#### Message from Jilli Rogerson

Hi all, I'm at the start of a steep learning curve having joined the School Governors this term! I've already learnt something new which I thought I'd share with you - just in case it's applicable some parents.

Free School Meals... doesn't just cover meals. If your child is in Reception to Year 2 you may have discounted this support because your child is already getting a free school meal!! However, I have learnt that regardless of the meal, the school is still eligible for a payment of over £1,000 for each child. This could be spent on swimming lessons, trips or even music lessons for <u>your</u> child if they are eligible. If they are eligible now, the child remains eligible until the end of primary school.

Your child may be able to get free school meals if you get any of the following:

- Income Support
- income-based Jobseeker's Allowance
- income-related Employment and Support Allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you apply on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)
